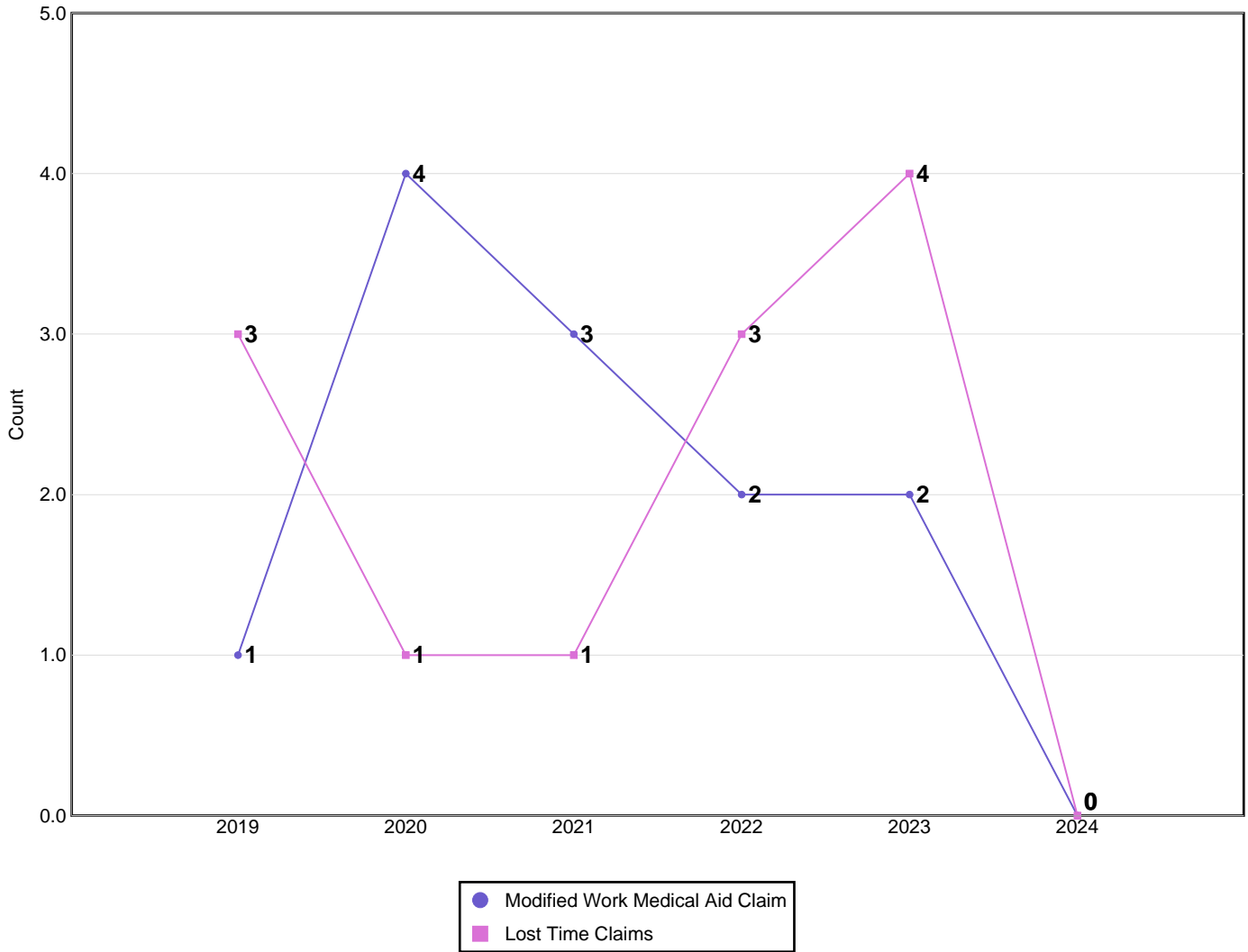

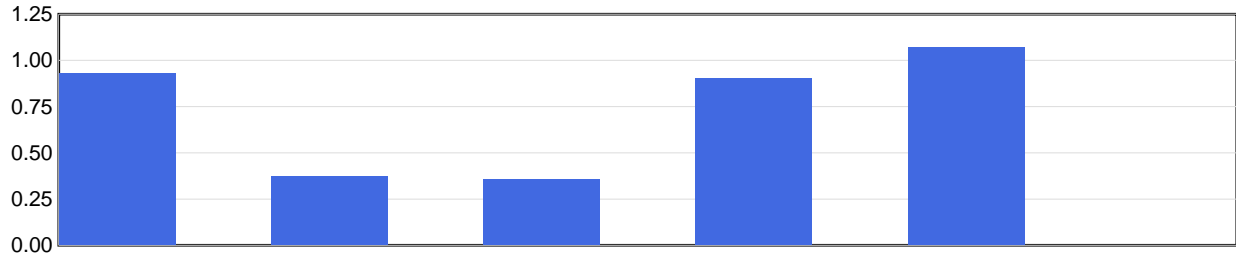

(Lost Time Claims per 100 Workers)



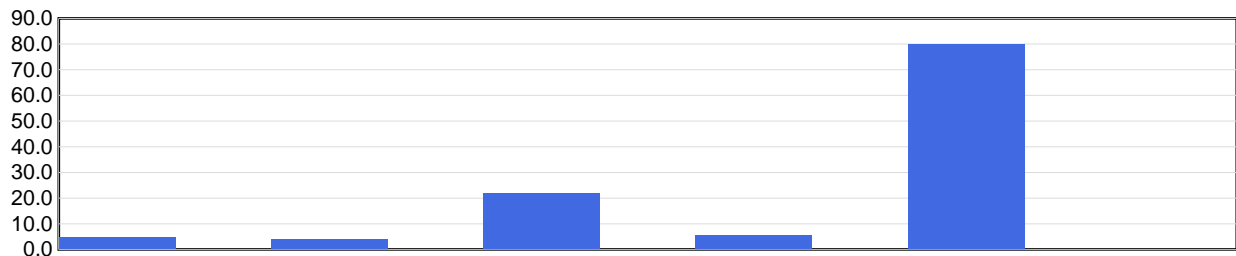

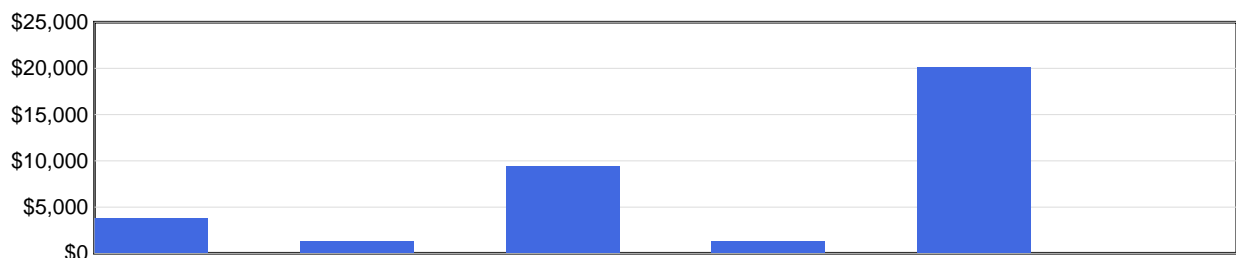

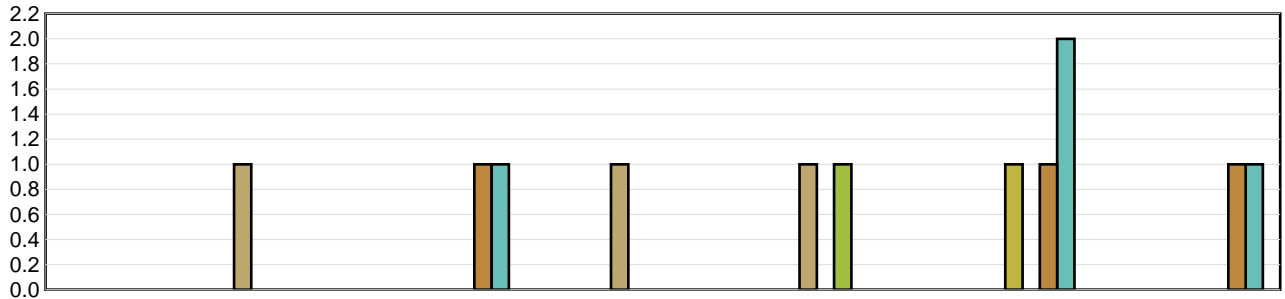

Number of LTCs

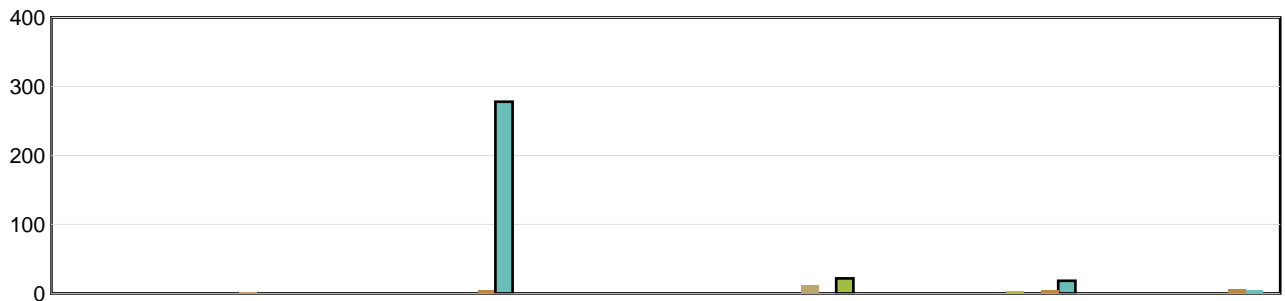
