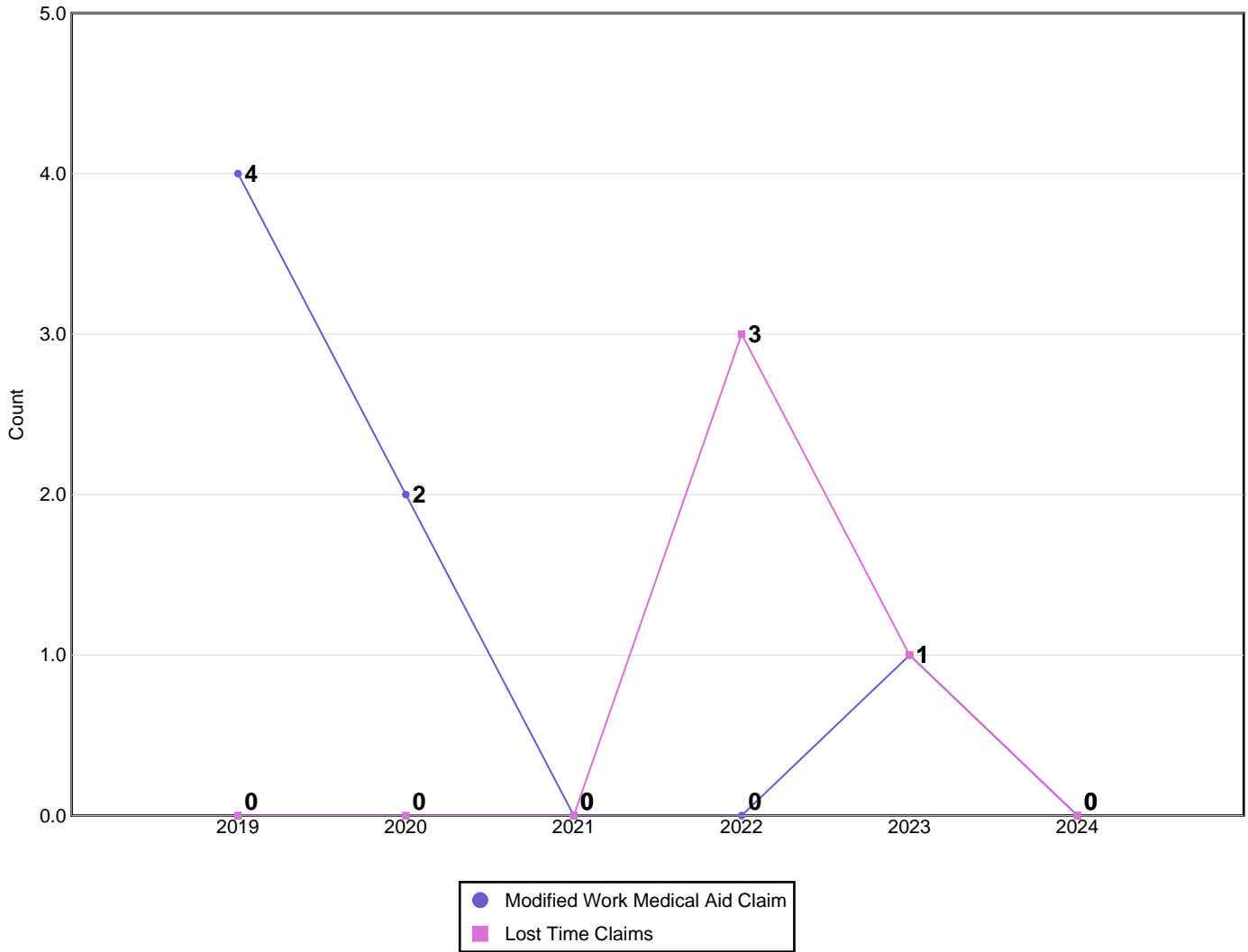

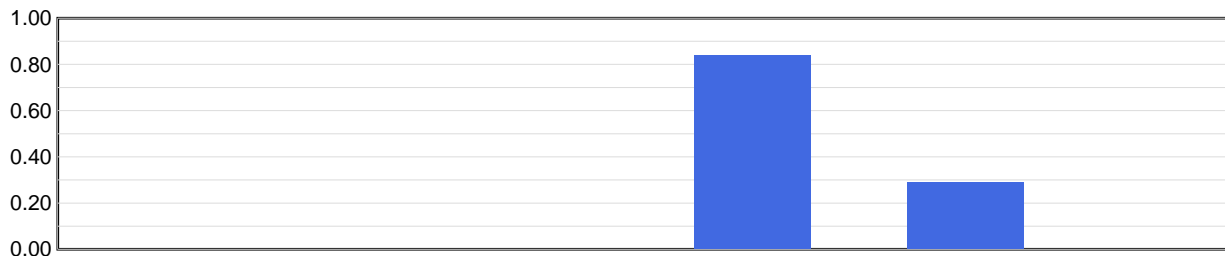

(Lost Time Claims per 100 Workers)



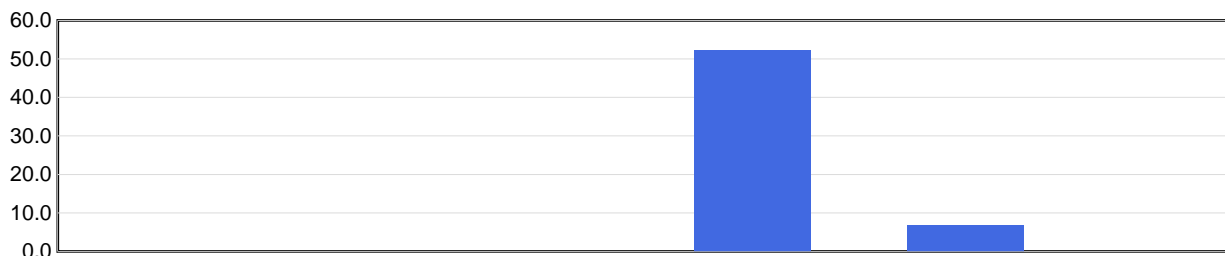

Severity Rates

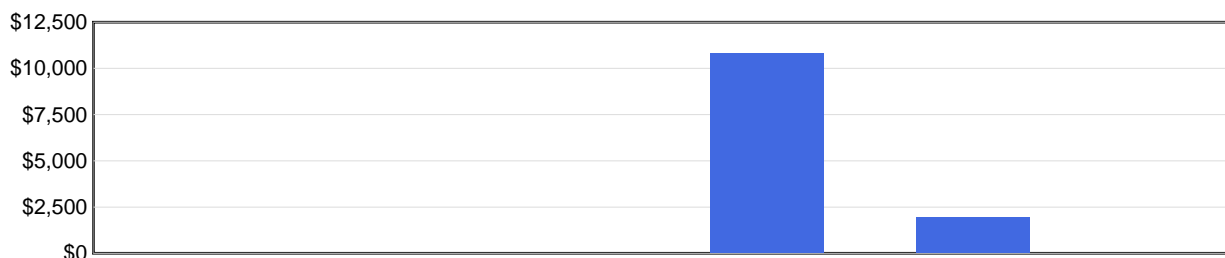

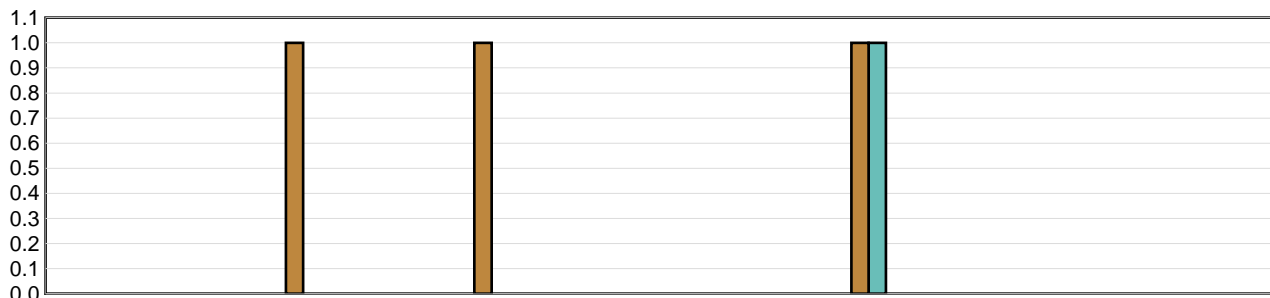

(by age of injured worker and by occurrence year)

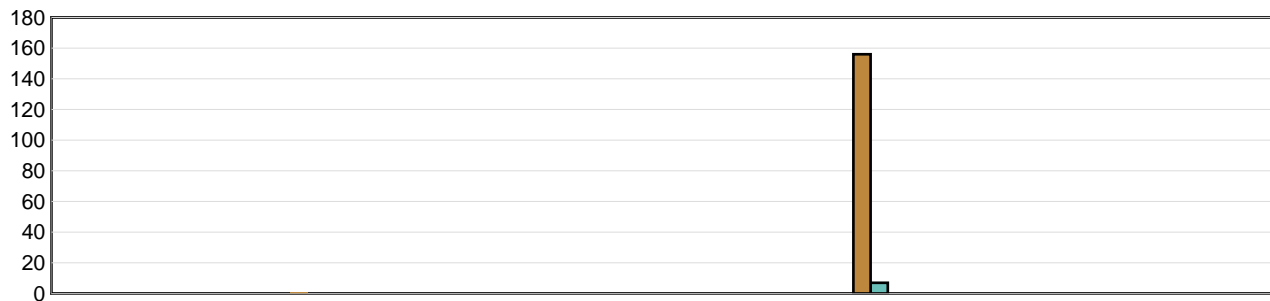
